

Colorado Child Care Contribution Tax Credit!

Wild Bear is not only Boulder County's non-profit all ages nature center, it is Nederland's ONLY school-age licensed child care facility.

When you or your business contribute funds to Wild Bear, you can get a 50% Colorado Tax Credit in addition to your regular state and federal contribution deductions. And you don't even have to have children to take advantage of it.

The table below illustrates how a large part of your donation comes back to you in various tax credits and deductions

<u>Your Contribution</u>	<u>\$500</u>	<u>\$1,000</u>	<u>\$5,000</u>
Colorado Child Care Tax Credit	(\$250)	(\$ 500)	(\$2,500)
Colorado Tax Savings	(\$ 25)	(\$ 50)	(\$ 250)
Federal Tax Savings	(\$ 150)	(\$ 300)	(\$1,500)
<u>Returned to you at tax time</u>	<u>\$425</u>	<u>\$ 850</u>	<u>\$4,250</u>
Your out of pocket cost	\$75	\$150	\$750

Instructions

This form is to be completed by the donee organization, then given to the donor. The donee organization should retain completed copies for record keeping.

Social Security number may be completed by the donor after receipt from the donee organization.

Donors shall submit this form with their Colorado income tax return when claiming the child care contribution credit. When filing electronically, attach this form as a PDF to the electronic return, upload a copy in Revenue Online or mail with form DR 1778.
